

ULANO GHOST REMOVER ADVANCE

Viscous cleaning agent for the removal of ghost images and mesh colourations

ULANO GHOST REMOVER ADVANCE is used for the removal of ghost images and mesh colourations. **ULANO GHOST REMOVER ADVANCE** can unrestrictedly be used on polyester meshes, do not exceed a reaction time of 1 hour on nylon or V2A meshes. When using V2A meshes its application can further be restricted due to varying qualities or pre-damages caused by other chemicals. Trials are essential. **ULANO GHOST REMOVER ADVANCE** is not suitable for metallized (nickel-plated) polyester mesh.

PROPERTIES

ULANO GHOST REMOVER ADVANCE quickly and safely removes ghost images and mesh colourations, especially those caused by Diazo sensitizers. Additional ink residue can be removed with solvents after treatment with **ULANO GHOST REMOVER ADVANCE**. Do not remove photoemulsion residue with **ULANO GHOST REMOVER ADVANCE**. A mixture of alkaline pastes and solvent cleaners or **ULANO ACTIGHOST RAPID GEL** is more effective. Ask your distributor for advice.

The viscosity of **ULANO GHOST REMOVER ADVANCE** allows a perfect coating on coarser mesh. Even after a longer reaction time, sufficient **ULANO GHOST REMOVER ADVANCE** remains on the mesh.

APPLICATION

Apply **ULANO GHOST REMOVER ADVANCE** with a V2A (stainless steel) coating trough onto both sides of the decoated and dried screen. Residue in the coating trough should be disposed of as **ULANO GHOST REMOVER ADVANCE** quickly absorbs contamination from the mesh which reduces the active components in the original container.

The standard reaction time should be at least 6 hours. Within this period the chloric active component is decomposed and no activated chlorine gets into the waste water while rinsing. We recommend a reaction time overnight (at approx. 20-23°C) as the working process is then disturbed least.

Notice: When applying **ULANO GHOST REMOVER ADVANCE** onto mechanically damaged or often decoated meshes, especially fine mesh may tear. However, this cleaning method is often the only possibility to reclaim the mesh. It is therefore recommended to test the suitability of the cleaner for specific applications beforehand, as any responsibility for torn screen mesh cannot be assumed.

Notice: Depending on the mesh brand and the reaction time, **ULANO GHOST REMOVER ADVANCE** may bleach dyed meshes.
